Subtle, elegant marble wall trimmings, dark mahogany tables, and a spacious marble counter complements their customers' dining pleasure, notwithstanding those cultural videos airing daily, on one of their three wall mounted TV's.

France's colonial impact on Senegal, ended approximately 50 years ago. French and Wolof are the spoken Senegalese languages often heard while dining. Thus, Chef Asta's more than 20 years' French meets Senegalese cuisine-legacy embodies flavorful appetizers, soups, among meats, poultry and seafood fusions. Each day, generous platters of fluffy Coucous, firm fish balls savored in a light delectable red peppers and onion gravy, and fresh salad greens are favorites, among Senegal's National Thiebou Djeun or Jolof Rice dish (fish stewed in a rich tomato sauce with cabbage, carrot, okra, red bell pepper, eggplant, squash, cauliflower and yucca, served with rice cooked in fish stock with a hint of tamarind). Lamb lovers gasp at their abundant lamb chunks.

Celebrating Black History

50 years since the Rev. Dr. Martin Luther King's and Nelson Farmer Handshake


My name is Nelson R. Farmer an 81 years old U.S. Army veteran and a retired professional photographer. Born in 1933 in Wilson, North Carolina, by third grade I was considered a very slow learner. My condition later diagnosed as a Certified Dyslexic, profoundly affected my future trials, tribulations, and triumphs, despite growing up in a middle-class household. At age 20, instead of receiving a high-school diploma, because I spent most of my teenage years learning photography, I received a certificate from our high school.

In 1964 this photo was taken at a church in LA, California during protests against the City's housing and other issues. Dr. Martin Luther King Jr. was on the speakers' agenda. Having photographed numerous celebrities, people of note and special events this became the best photographic moment in my career and life. I deeply admired Dr. King's dedication to civil rights, as I approached him for a brief introduction. As he shook my hand, I could not resist this exciting opportunity, and asked a nearby photographer to take this photo of Dr. King and I. This privilege and picture represent my life's highest motivational encounter. In the spirit of Dr. King, this photo motivates me to stand up and continuing fighting my battles for justice, including 20 years with my parents and their \$20,000 covering legal and medical costs during the 1990's after I received a small, U.S. Veteran's lump-sum retroactive, "non-service disability" payment.

Over the next four years, I devoted much of those funds to retaining proposal writers, accountants, legal advisors, typists and volunteers to establish my **IT'S A GOLF THING AND**

MORE THAN JUST GOLF NON-PROFIT.

My non-profits would help motivate "at risk," students overcome learning barriers, and become inspired to train to become great golfers, like Tiger Woods. In 1999' although the landmark Lamb Theatre on West 44th Street terminated our program there, to began renovations for their hotel, in the spirit of Dr. King, I didn't stop fighting for my "service related, disability" VA benefits. I set my sights on investing those funds for my youth golf programs.


Fort Campbell Army Base aggravated my disability. The day I arrived there, Officers told me I'd return home due to my low IQ. Fort Campbell disrupted my near enrollment at North Carolina trade school. At age 23, in 1954 I was Fort Campbell's Army base's only professional photographer using my 16 millimeter movie and another camera new that my Mother and Aunt bought me. About six months later Fort Campbell reduced my photo services, increased my hard labor task and refused my request for less physical chores. I was that 6 ft. 3in, 250 lbs. punished Black soldier, who roughly rebuked White soldiers racial and other stupidity slurs.

In 1956 Fort Bragg sent me home penniless, with my honorable discharge. My wife, two year old son, and me relocated to my parents' North Carolina. Photography is the only skill income I've had. When possible, I used my earnings to start various businesses

By 2003, I tried producing a **IT'S A GOLF THING AND MORE THAN JUST GOLF** youth fundraiser. By 2004 I left my New York-based International Denomination of Churches' fiscal agent, following consultants' advice to adequately secure funding by obtaining a 501C-3 for my non-profits. My non-profits became affiliates of the National Council of Minority Youth Golf Association, Minority Golf Association, New York's Professional Golf Association (PGA), Metropolitan Golf Association and recipients of

dozens of new and used golf clubs, and other golf equipment, but the fundraiser never occurred. In December 2013, **IT'S A GOLF THING AND MORE THAN JUST GOLF's** were refused 501C-3s, mainly due to not producing an income.

Following my last July 1st, 2013 VA hearings, I'm awaiting their verdict. A researcher's findings proved how the Army aggravated my disability, by violating Four Star U.S. Army



General Dwight Eisenhower's advice to avoid risking the lives of thousands U.S. uneducated soldiers, who could not read beyond third grade, which occurred during World War I. Using Ginzberg and Gates "Uneducated" studies Eisenhower reported that U.S. soldiers' with severe mental deficiencies were unfit to fight wars, if they couldn't read military orders, nor forms, nor write letters to families and love ones. I was that soldier, though some soldiers were sent home. Eisenhower, America's only shining Four and Five Star General, turned President of the United States during the 1950's, never fought in a U.S. war, due to his severe military training Army accident.

A Tribute to Social Workers: 50 years later

50 years ago on August 28, 1963 nearly 1 million people from the U.S. and abroad attended the March on Washington. They marched for jobs, freedom, education and social justice to end hostile discrimination of various persuasions.

I did not march on Washington, instead I represented New York City, together with major government officials at a week's conference in Puerto Rico. Nevertheless, the social work profession was well represented starting with the great, powerful speech by social work advocate Whitney M. Young, Jr, former Dean of Atlanta University School of Social Work and Executive Director of the National Urban League. Mr. Young's message to the Parent Teachers meetings, the voting booths and Sit In at corporate tables demanding equal pay for equal work still resonates throughout the social work community. While the social work profession is the back bone of human services for families and children, it is rarely placed in the forefront or acknowledged as a major force that it is.

In recognition of the powerful role of the social worker, Banks Enterprise and the National Black Theatre presented *The Living Platform: A Tribute to Social Workers*. The most recent

George Brash is host and producer of *The Culture Zone* airing on WPAT 930 AM, from 7 to 10 pm, on Saturdays. Born in 1957, in Mandeville, Jamaica during his first 15 years, he recalls hearing lots of music and social events announced on Jamaica's radio stations. In 1972 he moved to Queens, New York, and often traveled to Harlem, where classic R&B music of The Ohio Players, The Commodores and Aretha Franklin played in record stores, Harlem's sidewalks and the famous Apollo Theatre.

In 1979, at LaGuardia Community College, Brash's serious interest in radio was inspired by mounting racial tensions that he and other students faced within and outside of his college campus. He joined student associations, including LaGuardia's student government, where he met and interviewed ABC-TV'S *Like it Is TV Talk Show* host and producer Gil Noble, Stokely Carmichael and other political activists. As LaGuardia's President of the Student *Caribbean City Movement*, his broadcasting created leaders and listening voices for their Caribbean student body. Under Brooklyn's Medgar Evers' Professor Dr. Mary Umulu's tutelage, Brash's first *Youth in Progress* sponsored radio broadcasts thrived for 12 years as a regularly 91.5 FM radio program in New York.

Culture Zone's business, community, health political, cultural arts and entertainment radio programming commenced in 1990. Broadcasting on New York's WWRL 1600 AM, *Culture Zone* replaced his *Youth In Progress's* 91.5FM Radio Show at Medgar Evers. Brash's *Culture Zone's* appeal and message attracted larger listening audiences. Independently produced for eight years, *Culture Zone* activists' programming on WWRL1600AM, featured civil rights activist Rev Sharpton's campaign for Mayor interviews; racial protests against New York City police and related business and political social-economic issues.

Having endured the obstacles of becoming a successful independent radio producer, for more than three decades, he remains confident. Throughout the years, George Brash and the entire *Culture Zone* staff are



Eve Cornelious Society's Empowered Jazz Diva for Women's History Month

The challenge of replacing the worldly acclaimed renowned pianist Ramsey Lewis and celebrated Voice of Jazz Diva Eve Cornelious You-Tube CD has been difficult. Hearing any of her four CDs is more compelling. It's why Eve won Black Entertainment Television's BET-TV Jazz Discovery Award, and BET-TV awarded her with a 30-minute BET Jazz television segment that aired for years. She also hosted a BET-TV Jazzy Vocals' TV show.

A recipient of fine reviews, awards and more, Eve's March 12, 2014 Show, at ZEB'S PLACE, 228 West 28th St., New York, NY 10001 occurred almost two years after she performed at ZEB'S on 13, 2012, for which Pamela Chirappa wrote in JAZZ TIMES:

Eve Cornelious, one of the unforgettable great jazz voices in NY, enthralled her audience Wednesday, June 13th in the warm atmosphere of ZEB'S Place. Her alto soulful voice shaded with smoky hues enchanted the audience bringing back to life some of the most beautiful standards of the jazz repertoire. After some famous and exciting swinging tunes energetically performed and some graceful ballads, her ironical verve exploded with "Let him in", an 8 bars phrase on a marching tempo, about a woman's request to open her door (maybe to an unexpected lover?!). As the microphone passed by, dragged by the friendly atmosphere, everyone in the audience sang a proper interpretation of the lyrics. Of course anyone knows that subtle feeling between laziness and surprise that comes in certain evening so it became a coral performance: a very fun moment, a magic fusion of souls.

This was followed by an amazing interpretation of McCartney hit And I love her covered by Esther Phillips in the mid 60'. It seemed she knew the torture of love and the painful path of resurrection, connecting intimately with an audience more and more comforted by the subdued yet comforting sound of her voice. The eclectic creativity of Saul (Zebulon) Rubin on guitar mingled efficiently with the intense melodic bass of George deLancey and the measured, classy drums of Andrew Swift, creating a

comfortable field for the vivacious singer. She really knows how to impress the audience and suddenly a fast swing tempo on "Just one of those things" burned the air with a funny *giocoso* improvisation, where her rhythmical excellent skills showed up and made the audience ask for more. So she surrendered to the final tunes: a soothing yet soulful Skylark and a lively version of On green dolphin street which delivered wonderfully the final message: the beauty of love, life, jazz."

Born in Newark, New Jersey, she discovered her voice at the age of three. Always singing and humming, many times her brothers and sisters would implore her to 'be quiet' or outright tell her to 'shut up' while at the dinner table. "You can't sing," they teased. This contributed to her shyness, but she'd retreated to her favorite place to sing... the bathroom "It had a nice sound." Later, she learned this was called 'reverb'. "Our Family gatherings turned into talent shows where Gospel, R&B, Doo Wop, Blues and poetry were always on display. Everybody was a star! Naturally being a part of this artistically inclined clan, as well as participating in the church and school youth choirs, all fostered my love for music," Eve reminisced

She did not pursue an entertainment career. Instead with her Hampton University business degree, she became a sales representative for a major corporation. Later, unfulfilled, she and Tony, her son, relocated.

The call to New York City overwhelmed her, and exploring music led to her fine music career. Eve has performed and/or recorded with Ramsey Lewis' Sky Island; Norman Connors' Remember Who You Are; Javon Jackson's Easy Does It and currently, Nick Vintskevich's Vive L'Amour [which she co-wrote five tunes]. Chucho Valdez, Dr. Billy Taylor, Jon Hendricks, Mulgrew Miller, Dr. Lonnie Smith, Winard Harper, Mark Whitfield, Alvin Atkinson, Chip Crawford and Roy Hargrove.

She has traveled to many countries [recently Estonia, Russia, Kyrgyzstan, Turkey] and was a featured artist on albums recorded by The 'Call'. She's a featured vocalist at Smoke Jazz club in NYC, playing alongside stellar NY musicians: Jeremy Pelt, Clark Gayton, Anthony Wonsey, Carlton Holmes, Rodney Green, Bruce Harris, Andrew Klein, Lawrence Leathers, Lafayette Harris, David F. Gibson, Patience Higgins, Saul Rubin, Sherman Irby, Gerald Cannon Herman Burney and numerous others.

Eve's co-production of her *Faces of Eve, I Feel Like Some Jazz Today and Live @ Smoke* versatile, and openly creative albums embody



Jazz, Funk, Soul, Blues, R&B, Vocals and Compositions. The vocal rendition of Miles' *Flamenco Sketches* on IFLSJT is featured on the prestigious Smithsonian Institute Jazz-radio.

Though Known for her "Fashionista" style, be prepared for her to occasionally greet you as that intellectual Sister of Jazz Empowerment, definitively with her Jazz Composers Fellowship Award from the North Carolina Arts Council the INDIE Award; The Lionel Hampton Jazz Performance Award; And the Russian Jazz Performance Award. Her second and third North Carolina Central University (NCCU) Bachelors in General Music and Jazz reflect her great regards for jazz and its relative impact on other music genres.

As an impassioned educator, singer-songwriter who teaches music to all ages, worldwide, she was appointed as the first 'jazz vocal' teacher in North Carolina at East Carolina University. Her unrelenting mission to create, present and promote jazz music through concerts, festivals, clinics and academic residencies are noted with her curriculum programs. Devised and taught by Eve and guests lecturers, *Zzutainment* lectures and demonstrations for all age youth, tracing jazz history; *The Body and Soul Clinic* feature Various transcriptions of the composition, Body and Soul, is performed by legendary singers who have had an historical effect on vocal jazz debut at the International Association Jazz Educators, 2002. The Shepard Jazz Camp is Ages 11-16 studying jazz improvisation and jazz history; *JaZzfest!* - An original vocal festival conceived in Durham, NC presenting The Art of Jazz Singing introducing new and experienced singers this program created for a Jazz Endowment Scholarship Fund at NCCU.



June 2014 Few thespians other than **Ruby Dee** have received a Grammy, Obie, Emmy, Drama Desk, Screen Actors Guild's (SAG) Awards, including SAG'S *Lifetime Achievement Awards*, plus eight Emmy nominations. Born in Ohio, and raised in New York, in 1944 Ruby graduated with Hunter College's French and Spanish Degrees. Her honorary degree from Princeton University was awarded 65 years later. *Glowchild, and Other Poems*, (The Third Press 1972) was the first of four books published books written by Ruby Dee..

During her 53 years' marriage to legendary actor Ossie Davis, Ruby was a cast member of the *Guiding Light* soap opera for several years In 1990 she received an Emmy for her role in *Decoration Day Nominee*.

In 2007's starring in *American Gangster*, Ruby became history's second oldest Academy Award nominee. Baby boomers and mature seniors might recall Ruby's 1959 stage role, and 1962 film role in *Raisin in the Sun*.



May 2014 Years before becoming **Dr. Maya Angelou** She asked Civil Rights leader, Malcom X, to be the person to speak with African dignitaries on behalf of American Blacks, because she feared, she didn't have the same credibility. "I'm glad to present all that to the Schomberg" Angelou said during her 2010 ceremonial archive donation. The Story of Exclusiv Vodka





"I learned a lot about the value strategy of investment – about how a company is valued and what makes it a good investment. I wanted to create a company and a product that would over deliver on value to the consumer," Chistov said. "I set out to find something that would reach that happy medium – that would hit the sweet spot – between price point and quality."

Chistov began to sketch out the idea for creating a product that would hold a particular appeal for the American consumer – a standout vodka that would combine superior quality at the best possible price. He found the product he was looking for in Exclusiv Vodka's manufacturing plant in Moldova, a former Soviet republic that neighbors Chistov's native Ukraine. "Vodka is a new drink in the U.S. It only came to America in the 1950s, so its history here is less than 65 years old," Chistov explained. "In Russia, the tradition of vodka is 600 years old. Each town and each village has its own vodka. It's a matter of pride and culture. The best vodkas were kept for royalty and later the Soviet elite. This is the vodka from Moldova. A combination of the purest water and the finest winter wheat leaves a creamy taste on the palate." Since 2006, Chistov has worked tirelessly and almost singlehandedly to bring Exclusiv Vodka to the U. S. "We really want to deliver the best value possible to the American consumer," he said. To that end, Exclusiv has not relied on celebrity endorsements or a even a more traditional marketing campaign. "We've streamlined the manufacturing process and have eliminated non-essential pieces in the distribution chain," he said. "We have put that money back into the quality of the product. Our goal is to over deliver on value compared to other products on the shelf."

Chistov continues to introduce Exclusiv himself, market by market, and personally visits every retailer. "I run this business out of hotel rooms, my car and on my Blackberry," Chistov notes. The reception, he says, continues to be consistent across all markets – great taste, superior quality, excellent price. And this personal touch emphasizing quality and value continues to pay off, as company sales in 2012 reached \$15 million.




NO GUTS NO STORY (Select Books, 2010)

2 Timothy: 1:7 For thou has not given us the spirit of fear, but of power, and of love and of a sound mind.

Record-breaker, Giver and Winner, Rev. Al Sharpton's Dr. King's Renaissance Man, National Action Network's (NAN) April 9-11th, prodigious 16th Annual Convention raised the bar. Those Fortune 100's firms and other prestigious sponsors for NAN's Convention, will be remembered for their diversity support of this splendid event celebrating 50 Years Since President Johnson signed Congress' Civil Rights Act. Aside from a few ticketed events day one opened generously with 12,000 jammed pack exhilarated guests.

Some conventioners gained historic accessibility to see, hear, pose with, or shake hands with U.S. President Barack Obama, U.S. Attorney General Eric Holder, New York State Governor Cuomo and New York City's Mayor DeBlasio. Others were privileged to their first time, within reach of any of these politicians in the same venues that included interacting with business professionals, clergy, media, celebrities and academia, Civil Rights strategists conducting workshops and panel discussions.

Resolutely, NAN'S 16th Annual Convention, with members from 80 NAN chapters, diluted the "Politics and religion don't mix" 1984 Conservatives' slogan that stunted Rev. Jesse Jackson's U.S. Presidential Candidacy's success. Days before, throughout April 9, 2014, alarming U.S. airwaves, television and newsprint coverage about Rev. Sharpton failed. Their baseless, allegations and propaganda attracted more Rev. Sharpton aficionados and conscientious observers that became 2014's largest U.S. Civil Right's organization gathering. If Rev. Sharpton's exploits, with top law enforcement's assistance prevented more crime in our inner cities and nation, so be it, as per Biblical references to Jesus Christ's and his "fisher-of-men" disciples, entering strange places to preach the gospel.

With Chris Matthews, Tamron Hall, Rachel Maddow Crystal Ball, Joy Reid and other MSNBC-TV'S anchors and hosts serving as NAN'S panelists and moderators, it was rather astounding that Rev. Sharpton,

MSNBC-TV'S Politics Nation host received New York's WPIX-II TV'S coverage for their NAN's 16th Annual Convention. Richard Graziano, President of WPIX 11 asserted that "WPIX 11 is committed to civil rights and equality for all people. We are invested in the development of our community and are honored to be partnering with the NAN, to bring viewers access to the essential information presented at the Convention." Jay Dow WPIX 11's two time Emmy Award-winning correspondent addressed The Role of Media in Crafting the Social Narrative media panel, with Rev. Sharpton; Jonathan Alter, Newsweek's former Senior Editor; George Curry, Editor in Chief, NNPA; Katrina Vanden Heuvel, Editor and Publisher of The Nation, Joe Madison, host of The Joe Madison Show, Sirius XM Urban View and Desiree Rogers, President and CEO of Johnson Publishing.

"It is a blessing that Sharpton learned values from Martin Luther King and made it a way of life, since the U.S. Civil Rights Act," said Mayor DeBlasio, at the start of the April 9, 2011 Convention. New York's "stop and frisk" separate and unequal policing, has ceased."

The first day of the Plenary Session Moderator, U.S. Attorney General Eric Holder upheld Sharpton's law-abiding status, while emphasizing the importance of gun control and needs to revise America's drug laws. Raised by Barbudian parents in Elmhurst, Queens, gifted Holder, a graduate from NYC's elite Stuyvesant High School, and Columbia Law School, was the first U.S. African-American Associate Judge nominated by President Reagan; a District of Columbia Judge nominated by President Clinton; and Acting U.S. Attorney General nominated by President Bush. Governor Cuomo's special appearance also took place at NAN'S lavish Keeper of the Dreams Dinner Awards. NAN'S Board of Directors' Chairman Rev Dr. Franklyn Richardson's Welcome address paid homage

to leaders of the 1950's and 1960's resulting in the Civil and Voting Rights Act, signed by President Lyndon B. Johnson.

Reflecting Dr. King's Dreams and NAN's commitment to the precepts of Dr. King's Dream, the ceremony opened with *Keepers of the Dream Awards' Dinner* Co-Chair and NAN's National Board Member Tanya Lombard, Assistant VP, of Public Affairs. It was co-hosted by Wendy Williams, famous radio personality, Executive Producer/Host of the Wendy Williams' BET-TV Show, that airs 32 countries. Special remarks were made by Arnie Duncan, U.S. Secretary of Education. Honorees Bishop T. Curry, from New Birth Baptist Church, Miami, Florida received NAN'S Rev. Dr. Wyatt Tee Walker's Social Justice Award; Deborah Elaim, President of GE Foundation/GE Chief Diversity Officer NAN'S Humanitarian Award; Tamron Hall, Host of MSNBC'S News Nation and NBC-TV'S TODAY NAN'S Image Award, Gerald Hudson, International Executive VP, SEIU 400,000 United Healthcare Workers East NAN'S Activist Extraordinary Award; Rachel Noerdlinger, Chief of Staff, Chirlane McCrae, First Lady of NYC NAN'S Michael A. Hardy Award; Donald Thompson, President & CEO McDonald's Corporation - NAN'S Corporate Executive Award; Michael Weinstein, President AIDS Healthcare Foundation NAN'S Partnership Award. Acting Corporate Executive Director Janaye Ingram Eulogium provided a video presentation.

On April 11, 2014, four hours beyond schedule, President Obama told his rousing standing, packed house, guests to sit down. We ecstatically obeyed, considering how often we gingerly responded to the Event's noontime emergency evacuation announcements. For almost three hours, most guests

Bill de Blasio
Mayor of New York City

Since January 1, 2014 victorious NYC'S Progressive Mayor Bill DeBlasio is the 109th Mayor of NYC. By June 14, 2013 Mayor DeBlasio, together with his unified City Council members created the most concise, yet expansive balanced budget in record-time. DeBlasio has rapidly implemented some of the important initiatives he promised New Yorkers. By March 2014 Mayor DeBlasio's Pre-K Education plans to help accelerate youngsters' educational potential, was endorsed by NYC'S elected officials, among educators, community leaders and others. and social conscious stalwart for middle-class and under-served New Yorkers. He's modified some of his Charter school plans following meetings with Charter School scholars, academicians, consultants, business, clergy and community leaders. Who, in recent history has heard any Mayor announce construction plans of 200,000 affordable housing to rapidly commence during his first year in office? Such principles distinguished Mayor DeBlasio as a "Do it now" strategist's sense of urgency for affordable housing, for middle-class and working class' homeless families, among the homeless.

Dr. King among thousands of others abolitionists enslaved rebels and yester-years' Civil Rights' leaders would have proudly endorsed an integrated Black and White Couple, to reside in NYC's Gracie Mansion. Part of that slogan resonated among Black New Yorkers, during our City's 2013 Mayoral campaign. Mayor DeBlasio and African American's New York City's First Lady Chirlane McCray's were anxiously welcomed to reside in NYC'S Gracie Mansion, similar to millions of Americans overwhelmed by the site of our first Black President Obama and wife's presidential family' WhiteHouse's residency.

Within her husband's few months in office, New York's First Lady Chirlane, like U.S. First Lady Michelle, makes raves with and without their husbands. Like Michelle, her sophisticated and natural glamour does embellish any occasion. Both ladies are eloquent, and New York Global.biz publisher resents not attending the 2014 Black Institute's Tribute to Mayor DeBlasio's and First Lady DeBlasio, confirming how well family power works. Scott Stringer
City Comptroller

In 2013 when Scott Stringer was elected New York City's Comptroller, Scott had since aged 21 enjoyed six terms as one of New York's youngest State Assemblyman. Raised in Washington Heights, he attended New York City's public schools, and graduated from John

Jay College of Criminal Justice. Stringer's 13 years as an Assemblyman serving as NYS' Chair of Real Property Taxation, Oversight Analysis and Investigation committees. His Manhattan Borough Presidency implemented sweeping domestic violence, education, affordable housing, foods, transportation, environmental policies and government reforms. In 2012 New York City Immigrants received their first Immigration Handbook made possible by former Manhattan Borough President Stringer. During Stringer's two terms nearly 400 New York Community Board members were added, with a 40% African and Asian Americans Community Boards' membership increase, and 25% Latino Americans' Community Boards increase. His Community Planning Fellowship is expanding City-wide with joint cooperation from Mayor DeBlasio's Office and CUNY. Reportedly Stringer force majeure's Borough Presidency challenged Republic and others endeavoring to eliminate New York borough presidencies and public advocate elected officials.



Letitia James
Public Advocate

As Counsel and Chief of Staff to state assembly members, Letitia was aware that government could work in the public's interest. James worked on a law that gave grandparents rights in family court, and a bill that allocated money for reconstruction of the Franklin Avenue Shuttle and Atlantic Terminal Station. She also negotiated legislation pertaining to childcare, health care, and the protection of transit workers. In Albany, she worked with the Black, Puerto Rican and Hispanic Caucus, and other progressive Democrats. She is a public defender for the Legal Aid Society representing countless young individuals in the criminal justice system. As a member of the New York City Council, James introduced the Safe Housing Act, that became City law in 2007. This ground-breaking bill ensured that thousands of families in rental buildings receive prompt and full repairs to their apartments.



Eric Adams

Brooklyn Borough President

As NYC'S first Borough President, following his distinctive career upswing, from that as a former NYPD police officer before being elected in 2006 as a NYS Senator, Eric Adams keeps giving and winning. For over 30 years Eric Adams has worked to improve living conditions in Brooklyn. Amid the chaos, complaints were minimum, and most guests bore smiles.

About three hours later, despite our press credentials, we were scanned for security purposes, while police dogs sniffed whatever we carried. Such precautions confirmed Rev. Sharpton's *Giver and Winner's* power-brokerage. NAN's three day sojourn, fifty years since the President Lyndon B. He noted that the country was in a rapid growth and the middle class which barely existed, was now becoming a large population of people.

Nothing was being developed for them. Jay purchased some property that was near the city and approximately four miles from the ocean. At that time everyone thought he was crazy to do such a thing. The land was not developed even though it was an extremely beautiful and scenic location. People began to inquire about the land and he then developed the land. He reduced the property so the middle class could afford to live in this area. The developers would sell their land for \$45 to \$55 dollars a square meter, so he dropped his price to \$25 a square meter and assisted the buyer by financing it himself. People started purchasing the property and they would group together as families just to buy it. The location became prime property because it was close to the city of El Valle and overlooking the ocean. Jay still owns property there and has dealings in Panama to date. Jay began travelling back and forth to America more frequently until he decided to move back. He still travels back to Panama and he resides in New York.
